What is the Extent of Health Insurance for Foreign Nationals?

Health Insurance for Foreign Nationals covers the minimum benefit structure stated in the circular which numbered 16 under the date of 10.05.2016 with reference to health insurance issued for residence permit request and visa; and in the circular which numbered 9 under the date of 06.06.2016 with reference to private health insurance issued for residence permit request.

What guarantees are included in the scope of the policy?

Outpatient treatment expenses in contracted and non-contracted healthcare providers are covered at 60% payment rate up to TL 2.000. Inpatient treatment expenses are covered in contracted healthcare providers at 100% payment rate with no limits; in non-contracted healthcare providers at 80% payment rate up to TL 20.000.

Is there any age limit to be insured under the policy?

The policy covers up to age 64. Children under the age of 18 can only be insured with their parents.

Who can be insured under the policy?

Exclusively foreign individuals can be covered under the policy. Turkish citizens cannot be covered under the policy.

Is the policy valid abroad?

Health Insurance for Foreign Nationals is only valid within the borders of the Republic of Turkey. Turkish Republic of North Cyprus is excluded.

Inpatient Treatment expenses are covered at 100% payment rate with no limits in the contracted healthcare providers under the coverage of the Health Insurance for Foreign Nationals.

The coverage information under the insurance is stated below.
